### **TO OUR Community**

The year 2021 was exciting for CIRC Action Fund. We began implementing our vision to become a full-time political and advocacy organization. For the first time, we created a non-electoral year budget to allow our talented staff to support our legislative work and strategize with immigrant communities on building local power.

In the first few months, our full-time CIRC Action Fund team coordinated an ambitious lobbying and legislative communications strategy to build political power in the State Capitol. We helped prepare our directly impacted members, managed relationships with legislators, supplied critical op-eds to build public support in key legislator districts and coordinated strategy with our campaign steering committees and lobbyists. This infrastructure was critical in passing Colorado's Legal Defense Fund and a bill on data privacy.

In the fall, we made endorsements for municipal elections across the Denver-metro region and helped elect three candidates. Our wins in Aurora ensured the City Council did not become a conservative majority — an example of how local races invoke change. In fact, the election was tainted by more than \$1 million in investments by national ultra-right wing forces in only one city council district.

For the November election, we returned to in-person canvassing after running an entirely remote campaign in 2020 due to COVID. While we are proud of our wins, we witnessed some challenges including lowered voter turnout, especially in communities of color, which we expect will continue this year. But, through our commitment to our communities, our values and our vision for change, we hope to turn this trend around in the communities in which we work.

The year 2022 is critical for our movement. While Trump was defeated in 2020, the forces he represents are still hard at work, and it will take an inspired and coordinated effort to defeat them. The CIRC Action Fund team is deeply committed to continue building political power for our immigrant communities in 2022 and beyond. We are grateful to all those who contributed in any way to our movement — especially to our organizers, volunteers, and donors — and we hope to have your continued support and enthusiasm this year.



# IN THE LEGISLATURE

CIRC and CIRC Action Fund were able to pass the following bills:

 HB21-1194-to create an Immigration Legal Defense Fund, which creates a grant program to provide legal representation for Coloradans with deportation cases.
Passing HB21-1194 also makes Colorado one of the first states in the nation to create a statewide legal defense fund program through statute.



 SB21-131-to Protect Personal Identifying Information Kept By State, which limits ICE's access to state databases, in particular the DMV.





# IN THE LEGISLATURE

- Our work allowed us to accumulate a significant amount of political capital, which in turn helped us pass our bills.
- We focused on coalition building and organizing political entities that CIRC didn't have access to - such as other advocacy groups, PACs, county democratic parties and clubs, democratic party caucuses - to help move and lobby specific lawmakers.
- CIRC Action also supported our CIRC lobbying team by leading a legislative communications campaign that focused on attaining both earned media and social media exposure to our priority legislative issues.











## COMMUNITY ENGAGEMENT



We accumulated more than 50 media hits for both campaigns. Many of those included letters to the editor and Op-Eds written by CIRC members.



A close collaboration between CIRC and CIRC Action Fund during the legislative session and a robust communication strategy are key campaign activities we will continue in future sessions.



## ACCOUNTABILITY

#### **2021 Legislative Session** We held Hickenlooper accountable and pushed him to co-sponsor the U.S. Citizenship Act, the SECURE Act, and the Citizenship for Essential Workers Act.


